### Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change all versions of a program--to make sure it remains free software for all its users. We, the Free Software Foundation, use the GNU General Public License for most of our software; it applies also to any other work released this way by its authors. 0. Definitions.




- Self-contained package format
- Keeps operating system separate from applications
- Provides stability to users desktop experience

- A closer look at PBIs -
- Based upon the philosophy that applications are NOT the operating system.
- Packages are self-contained, I.E. include required files / libraries within.
- Does not change installed system packages.






- PBI re-implementation for 9.0 -
- Addresses several issues present in original implementation
  - Tacked on CLI interface
  - Wasted space due to not sharing libraries
  - Weak distribution infrastructure
  - No digital signatures
  - Large file updates


- PBI9 Command-line Interface -
- PBI toolchain implemented in shell for portability
- All PBI functionality available via CLI
  - pbi\_browser
  - pbi\_repo
  - pbi\_add


- PBI9 Intelligent Library Sharing -
- Allows sharing of identical files / libraries between PBIs with hard-links
- Reduces disk / run-time memory usage
- Tracking of matches with sha256 checksum
- Monitored and managed by the pbid daemon














- PBI9 Distribution -

- Provides mechanism for PBI creators to distribute PBI files to end-users
- Integrated with digital signatures
- Allows maintaining both a master INDEX of released PBIs, along with meta-index of PBI information
- Users can browse the meta-index, and download PBIs from repo, or perform updates of older PBIs to newer versions.

- PBI9 Digital Signatures -

- Digital signatures using openssl
- Archive and installation scripts individually signed during PBI creation
- End user or front-end can verify signatures with pbi\_add command.

- PBI9 Binary Patching -

- Allows updating of PBIs with smaller downloads
- In some cases a 95% size reduction
- Uses bsdiff / bspatch for patching process
- Auto-generation of patch files from port builds
- Auto-fallback to full-patching if bspatch fails

- Graphical AppCafe -

- QT4 Based front-end to "pbi\_browser"
- Allows installing applications as user account
- Support for browsing and managing repos, mirrors, etc
- Notifier tray icon for updates
